#### I. Recommendations

Following is a summary of the Select Special Committee on Electoral Boundaries' recommended changes to the Electoral Boundaries Commission Act, see Appendix A.

#### 1. Number of Electoral Divisions

The number of electoral divisions in Alberta shall be 83.

#### 2. Basis for Redistribution

The basis shall be population based on the most current census as outlined by Statistics Canada set out in the document entitled A National Overview<sup>1</sup>. Added to this base shall be population data from Indian and Northern Affairs Canada for all incompletely enumerated Indian Reserves and Indian Settlements, as identified in A National Overview, to compensate for individuals not counted in the 1991 census. The 1991 Census for Alberta is 2,545,553. The Indian population for incompletely enumerated Indian Reserves and Indian Settlements is 9,226. The grand total population of Alberta is 2,554,779.

The guidelines used in every case to determine the size, make-up, population and boundaries of each constituency were consistent with Provincial and Supreme Court decisions relating to electoral divisions.

#### 3. Special Consideration Electoral Divisions

As endorsed by the Alberta Court of Appeal, the population of an electoral division must not be more than 25% above nor more than 25% below the average population of all the proposed electoral divisions. In fact, the average plus/minus percentage variations (excluding the special consideration electoral divisions) are significantly lower than court accepted parameters of plus/minus 25%. However up to 5% of Alberta's electoral divisions may have a population that is as much as 50% below the average population of all the electoral divisions if three of the following criteria exist in an electoral division:

(a) the area of the proposed electoral division exceeds 20 000 square kilometres and/or the total surveyed area of the proposed electoral division exceeds 15 000 square kilometres;

- (b) the distance from the Legislature Building in Edmonton to the nearest boundary of the proposed electoral division by the most direct highway route is more than 150 kilometres;
- (c) there is no town in the proposed electoral division that has a population exceeding 4000 people (for the purpose of this subsection, the Municipality of Crowsnest Pass is not a town);
- (d) the area of the proposed electoral division contains Indian and/or Metis population living on reserves or settlements;
- (e) the proposed electoral division has a portion of its boundary coterminous with a Province of Alberta boundary.

The committee determined that four electoral divisions qualified as Special Consideration Electoral Divisions, two in Northern Alberta, one in Central Alberta and one in Southern Alberta, namely, Athabasca-Wabasca, Lesser Slave Lake, Chinook and Cardston-Chief Mountain.

Athabasca-Wabasca met four points a) c) d) and e), Lesser Slave Lake met four points a) b) d) and e), Chinook met four points a) b) c) and e), and Cardston-Chief Mountain met four points b) c) d) and e).

#### 4. <u>Single Municipality Electoral Divisions</u>

Single municipality electoral divisions shall increase in Calgary from 18 to 20, namely: Calgary-Bow, Calgary-Buffalo, Calgary-Cross, Calgary-Currie, Calgary-Egmont, Calgary-Elbow, Calgary-Fish Creek, Calgary-Foothills, Calgary-Glenmore, Calgary-Lougheed, Calgary-McCall, Calgary-Millican, Calgary-Montrose, Calgary-Mountain View, Calgary-North Hill, Calgary-North West, Calgary-Nose Creek, Calgary-Shaw, Calgary-Varsity, and Calgary-West.

Single municipality electoral divisions shall increase in Edmonton from 17 to 18, namely: Edmonton-Avonmore, Edmonton-Belmont, Edmonton-Centre, Edmonton-Ellerslie, Edmonton-Glengarry, Edmonton-Glenora, Edmonton-Gold Bar, Edmonton-Highlands, Edmonton-Manning, Edmonton-Mayfield, Edmonton-McClung, Edmonton-Meadowlark, Edmonton-Millwoods, Edmonton-Norwood, Edmonton-Roper, Edmonton-Rutherford, Edmonton-Strathcona, and Edmonton-Whitemud.

The total number of single municipality electoral divisions shall be 44 namely: Calgary and Edmonton, as above, plus: Fort McMurray, Lethbridge-East, Lethbridge-West, Medicine Hat, St. Albert, and Sherwood Park.

#### 5. Multi-Municipality Electoral Divisions

Multi-municipality electoral divisions shall total 39, namely: Athabasca-Wabasca, Banff-Cochrane, Barrhead-Westlock, Bonnyville, Bow Valley, Cardston-Chief Mountain, Chinook, Clover Bar-Fort Saskatchewan, Cypress-Medicine Hat, Drayton Valley, Drumheller, Dunvegan, Grande Prairie-Smoky, Grande Prairie-Wapiti, Highwood, Innisfail, Lac La Biche-St. Paul, Lacombe-Stettler, Lakeland, Leduc, Lesser Slave Lake, Little Bow, Olds-Didsbury, Peace River, Pincher Creek-Macleod, Ponoka-Rimbey, Red Deer-North, Red Deer-South, Redwater, Rocky Mountain House, Spruce Grove-Sturgeon, Stony Plain, Taber-Warner, Three Hills-Airdrie, Vegreville-Viking, Wainwright, West Yellowhead, Wetaskiwin-Camrose, and Whitecourt-Ste. Anne.

#### 6. Length of Time Between Redistribution

Redistribution shall occur after the detailed enumeration area results are released from Statistics Canada following each ten year census. Therefore the next redistribution would occur following the release of detailed enumeration area data from the 2001 census.

#### 7. Public Hearings

Public Hearings must be held before and after future Electoral Boundaries Commissions prepare their Interim Report. This will ensure that future Commissions have public input prior to the development of an Interim Report.

#### 8. Alberta Electoral Boundaries - Legal Descriptions

Following are the legal descriptions for the 83 electoral divisions recommended by the Select Special Committee on Electoral Boundaries. Maps outlining the boundary of each electoral division are in the Map Pocket at the back of the report. A list at the conclusion of the legal descriptions gives the name of each electoral division, the population and the population variation from the average.

All that portion of the Province of Alberta contained within the boundary as follows: commencing at the intersection of the centre line of Sarcee Trail and the centre line of 69 Street N.W.; thence south along the said centre line of 69 Street N.W. to its intersection with the Calgary City Boundary as of October 1992; thence west, north, west, north and easterly along the said city boundary to its intersection with the left bank of the Bow River; thence downstream along the said left bank to the centre line of the west production of 32 Avenue N.W.; thence east along the centre line of the west production of 32 Avenue N.W. and the centre line of 32 Avenue N.W. to its intersection with the centre line of Shaganappi Trail N.W.; thence south along the said centre line to its intersection with the centre line of the Trans Canada Highway (16 Avenue N.W.); thence easterly along the said centre line to its intersection with the centre line of 10 Street N.W.; thence southerly along the said centre line to its intersection with the right bank of the Bow River; thence upstream along the said right bank to its intersection with the north boundary of the Wildwood Community District; thence northwesterly and south along the said boundary to its intersection with the centre line of Sarcee Trail; thence northwest along the said centre line to the point of commencement, in conjunction with 1991 Community Districts Boundaries for Bowness, Greenwood/Greenbriar, Hillhurst,

Hounsfield Heights/Briar Hill, Montgomery, Parkdale, Point McKay, St. Andrews Heights, and West Hillhurst.

#### **CALGARY - BUFFALO**

All that portion of the Province of Alberta contained within the boundary as follows: commencing at the intersection of the centre line of 17 Avenue S.W. and the centre line of 24 Street S.W.; thence north along the said centre line of 24 Street S.W. and the centre line of a north production of 24 Street S.W. to its intersection with the right bank of the Bow River; thence downstream along the said right bank to its intersection with the right bank of the Elbow River; thence upstream along the said right bank to the south boundary of the Mission Community District; thence southerly and west along the said boundary to its intersection with the south boundary of the Cliff Bungalow Community District; thence south and northerly along the said boundary to its intersection with the control boundary of the Upper Mount Royal Community District; thence northwesterly along the said boundary to its intersection with the centre line of 14 Street S.W.; thence north along the said centre line to its intersection with the centre line of 17 Avenue S.W.; thence west along the said centre line to the point of commencement, in conjunction with 1991 Community Districts Boundaries for Chinatown, Cliff Bungalow, Connaught, Downtown Commercial Core, Downtown East Village, Downtown West End, Eau Claire, Lower Mount Royal, Mission, Scarboro, Sunalta, Scarboro/Sunalta West, and Victoria Park.

#### **CALGARY - CROSS**

## 10. Extraneous Recommendations

The extraneous input to the Final Report of the Electoral Boundaries Commission, 1983-84 chaired by the Honourable Mr. Justice Russell A. Dixon is outlined below.

## Listing of Extraneous Input

# Submitted to the Electoral Boundaries Commission 1983/84

As indicated in the Final Report prepared by the Electoral Boundaries Commission and submitted to the Speaker, the following represents certain extraneous public input submitted to the Commission during the course of the Public Hearings and which concerns matters involved with the electoral process in the Province of Alberta, but is outside of the terms of reference of the Commission.

The submissions included the following:

- a) proposals questioning the need to expand the number of electoral divisions from 79 to 83 in view of the added costs involved in the additional representation and the lack of evidence that additional representation is required when comparing voter population/representation in Alberta and other Provinces such as British Columbia, Ontario and Quebec;
- b) recommendations and suggestions that a more equitable system of voter representation be clearly spelled out in Part 2 of the Electoral Boundaries Commission Act. Proposals included the setting up of a separate Commission or body to review the urban-rural mix and the need to make electoral boundaries and local County and Municipal District boundaries co-terminous wherever possible. In addition, it was recommended that the Rules in Part 2 of the Statute should be expanded to apply the "25 percent above or below average" formula to both urban and rural electoral divisions;
- c) recommendations that a new classification of urban/rural electoral divisions be recognized in the Act to provide for those rural areas containing a densely populated municipality, i.e. Grande Prairie, Fort McMurray.

All of these suggestions have been incorporated as fully as possible into the work of the Select Special Committee on Electoral Boundaries 1989-90 and the Select Special Committee on Electoral Boundaries established July 2, 1992.

For the future the Select Special Committee on Electoral Boundaries would like to put forward three suggestions. **One**, that the Province of Alberta work with other Canadian provinces to develop a definition of "effective representation" within the

Charter of Rights and Freedoms. This would ensure there is a clear Canadian understanding as to the process of balancing population, demographic and geographical considerations in relation to tenants of the courts.

Two, the Select Special Committee on Electoral Boundaries unanimously recommends that the Member's Services Committee Order No. MSC 4183, Transportation and Administration Service Order, be amended by adding provisions to allow Members of the Legislative Assembly representing Special Consideration electoral divisions to have access for charter flights on an as required basis.

The committee recommends that the Member Services Committee examine other provisions provided to Members of the Legislative Assembly representing rural areas, most specifically Members of the Legislative Assembly representing Special Consideration Electoral Divisions, to ensure the best possible access of constituents to their Member of the Legislative Assembly.

Three, in 1971, Alberta was the first jurisdiction in the Commonwealth to provide live television coverage of the proceedings of its Legislative Assembly. Gavel to gavel coverage was provided from 1971 until 1982 at which time, due to cost considerations, coverage was reduced to the 45-minute daily Question Period.

Although the Alberta Legislative Assembly has continued to provide television coverage of daily Question Period, greater accessibility to, and understanding of, the participation required of all MLAs in the Legislative process can only be afforded to the public by a return to gavel to gavel coverage.

# II. Background

### 1. Overview

Following the report of the Select Special Committee on Electoral Boundaries (November, 1990) the Electoral Boundaries Commission Act was created, Chapter E-4.01, 1990.

The ensuing Electoral Boundaries Commission produced an Interim (December, 1991) and Final Report (May, 1992). The Final Report was comprised of an individual report by each of the Commission's five members. Due to the lack of a majority decision the Legislature passed the following motion July 2, 1992.

Moved by Hon. Mr. Anderson:

Be it resolved that

- (1) A Select Special Committee on Electoral Boundaries be established consisting of 7 members of the Assembly, 4 members appointed by the Government caucus, one of which shall be chairman and another shall be vice-chairman, 2 members appointed by the caucus of the Official Opposition and one member appointed by the caucus of the Liberal Opposition.
- (2) If either Opposition caucus does not appoint its members to the Select Special Committee on Electoral Boundaries before its first meeting, such members may be appointed by the other Opposition caucus.
- (3) The Select Special Committee is charged with making recommendations to the Assembly for the establishment of new electoral boundaries in the province taking into consideration:
  - (a) the May 1992 final report, including the individual reports of each member of the Electoral Boundaries Commission,
  - (b) any legislation, legal decisions, and historic and current practices of Alberta or other Canadian jurisdictions relating to the distribution of constituencies and their boundaries, including the Charter of Rights and Freedoms,
  - (c) any geographic, demographic, community interests and other factors that should be considered in the distribution of constituencies and the determination of their boundaries using 1991 census data,
  - (d) the impact of the determination of constituency boundaries on the ability of members of the Legislative Assembly to fully discharge their duties to their constituents,
  - (e) any information or evidence, obtained within the province relevant to any other factors that the Select Special Committee on Electoral Boundaries reasonably considers essential to the discharge of its duties.
- (4) The Select Special Committee on Electoral Boundaries may make long-term recommendations with respect to the process of determining electoral boundaries including the establishment of commissions, committees or other bodies and the mandates of those commissions, committees or other bodies.

- (5) Reasonable disbursements by the Select Special Committee for staff assistance, equipment and supplies, public information needs, rent, travel, and other expenditures necessary for the effective conduct of its responsibilities shall be paid, subject to the approval of the Chairman.
- (6) In carrying out its responsibilities, the Select Special Committee may, with the approval of the Speaker of the Legislative Assembly, utilize staff employed by the Legislative Assembly.
- (7) The Chairman and members of the Select Special Committee shall be paid in accordance with the schedule of Category "A" Committees provided in Members' Services Committee Order 10/89.
- (8) The Select Special Committee on Electoral Boundaries shall report by November 15, 1992 to the Assembly if it is then sitting, or if the Assembly is not then sitting, shall deposit a copy of its report with the Clerk of the Assembly and forward a copy of its report to each member.

The Government named Bob Bogle, MLA Taber-Warner, as Chairman, Stockwell Day, MLA Red Deer-North, Vice Chairman, Patricia Black, MLA Calgary-Foothills, and Mike Cardinal, MLA Athabasca-Lac La Biche. The Official Opposition and the Liberal Opposition chose to not participate in the process.

The Select Special Committee on Electoral Boundaries studied and drew heavily on all documents, submissions, transcripts, research and data that resulted from the work of the Select Special Committee on Electoral Boundaries (1989-1990) and the Electoral Boundaries Commission (1991-1992).

## 2. <u>Meeting Arrangements</u>

The first meeting of the Select Special Committee on Electoral Boundaries was held on July 29, 1992. Meetings were held in the Select Special Committee on Electoral Boundaries Office at 1001 Legislature Annex, 9718 - 107 Street, T5K 1E4 and at McDougall Centre, 455 - 6th Street S.W., Calgary, Alberta, T2P 4E8. Meetings, except for in camera segments, were open to the public and recorded by Alberta Hansard. An embargo was placed on Hansard transcripts until the Committee's report was completed and released to the public. Hansard transcripts of the meetings will be filed in the Legislature Library and available to the public. Minutes will be available from the Legislature Library by December 31, 1992.

Following are a number of guiding points made and quotations used by the consultants who met with the committee.

### Mayor Al Duerr, City of Calgary Mayor, Jan Reimer, City of Edmonton

Points stressed by both Mayors included:

- Use 1991 census data.
- Keep size of the Legislature at 83, but increase seats for both Calgary and Edmonton.
- Do not use "rurban ridings".
- Respect "community of interest" and use existing community boundaries.

## Gary Browning, Alberta Urban Municipalities Association

(Representing 292 municipalities that range from small villages to towns and cities including Calgary and Edmonton).

- Stressed the importance of each municipality presenting their respective recommendations regarding Electoral Boundaries.
- Spoke eloquently of the make-up of Alberta, going from the small rural communities, intermixing with our larger towns and cities, including the two metropolitan centres.

Ken Albrecht, President, Rural and Improvement Districts Association Gordon Miller, President, Alberta Association of Municipal Districts and Counties

Gordon Miller: "A quotation I would like to share with you is from the late Grant Notley, the former leader of the New Democratic Party of Alberta and a former MLA for a rural Alberta constituency. The quotation is from Hansard of May 12, 1977, and reads as follows:

If one had come to me seven or eight years ago and said we should provide some sort of special consideration for rural constituencies, I wouldn't have been very sympathetic. As a matter of fact in 1970, I recall making some rather harsh statements outside the House about the recommendations of the Electoral Boundaries Commission at the time and the fact that there was not rigid representation by population. But in the last six years there is no doubt in my mind that there are some very real problems in representing rural Alberta, which must lead us to the conclusion that rigid application by population is not fair. It may be fair in an abstract, philosophical sense, but in my judgment it is not fair in terms of providing access by the electorate to their member of the Legislature.

I think it just happens to be a fact that rural MLA's have a higher volume of constituency business, because there is greater interest, a perception of the MLA as a representative of people which is more clearly understood and, somehow, defined in the rural area than the average urban constituency."

- Use existing constituency lines as much as possible.
- When change must be made, follow county and municipal district lines wherever possible.
- Ridings in extreme north should run north/south rather than east/west due to transportation and communication lines.
- An individual's access to a Member of the Assembly is very important.

As well all the current 83 Members of the Legislative Assembly were invited to meet with the committee to discuss their respective electoral division. A number of Members of the Legislative Assembly from both government and opposition met with the committee or submitted written comments.

### 5. Committee Deliberations

### A) General

In conjunction with the requirements of the Electoral Boundaries Commission Act, 1990, along with the amendments unanimously agreed to by the Select Special Committee on Electoral Boundaries, the committee was guided by the following principles;

### i) Co-terminous Boundaries

The committee endeavoured to follow existing electoral boundaries wherever practical; and/or

- a) to follow municipality boundaries wherever possible;
- b) to follow community lines within Alberta's two major cities.

### ii) Access to Member of the Legislative Assembly

The committee endeavoured to ensure that constituents have the most effective access to their Member of the Legislative Assembly

The committee spent considerable time and effort to review the 486 submissions and presentations to the Select Special Committee on Electoral Boundaries 1989-90 and the 823 submissions and presentations made to the Electoral Boundaries Commission 1991-92. As part of their deliberations the committee made every effort to give consideration to the various ideas, suggestions and comments presented over the past three years by Albertans.

The Select Special Committee on Electoral Boundaries, created July 2, 1992, was very grateful for the 1,309 submissions that had been submitted prior to July 2, 1992, and would like to acknowledge the submissions sent in after July 2, 1992. These contributions were appreciated and read into Hansard;

### B) Names

The committee used existing electoral district names whenever possible. In a number of instances changes of names were required when situations arose wherein the name of a community appeared in the existing electoral division title but was no longer located within the new electoral division.

The committee used traditional or historical references whenever new names were required in Calgary and Edmonton.

The new riding of <u>Calgary-Cross</u> was named after Alfred Ernest Cross, born in Montreal in 1861 and moved to the Calgary area where he became involved in ranching. He founded the Calgary Brewing and Malting Company in 1893. A founding member of the Western Stock Growers Association and the Calgary Board of Trade, he was also one of the four founders of the Calgary Stampede. In 1899 Mr. Cross was elected to the territorial assembly in Calgary East as an Independent. His final speech in the assembly argued for provincial status for Alberta and Saskatchewan. A.E. Cross died in 1932.

The riding of <u>Calgary-Lougheed</u> was selected in recognition of the Honourable Peter Lougheed who was born in Calgary, Alberta on July 26, 1928. In 1950 he received a Bachelor of Arts degree and in 1952 a Bachelor of Laws degree from the University of Alberta. Mr. Lougheed obtained his Master of Business Administration from Harvard and returned to Calgary and worked in the private sector. He became Leader of the Progressive Conservative Association in 1965 and was first elected to the Alberta Legislature in 1967 serving as Leader of the Official Opposition until 1971 when he became Premier. Peter Lougheed was Premier until 1985 when he resigned and returned to Calgary.

Ernest C. Manning was chosen for recognition in the Edmonton-Manning Electoral Division. The Honourable Ernest C. Manning was born in 1908 at Carduff, Saskatchewan. Ernest Manning was elected to the Alberta Legislature in 1935 as a member of the Social Credit Party representing Calgary. In the 1940 election he represented Edmonton until redistribution for the 1959 election when he represented Strathcona-East. He was named Premier in 1943 and served in that capacity until 1968 giving him the honour of being Alberta's longest serving Premier. Mr. Manning was appointed to the Senate of Canada in 1970 where he served until 1983. He currently resides in St. Albert, Alberta.

Edmonton-McClung electoral division was named after the Honourable Nellie Letitia McClung who was born at Chatsworth Ontario in 1873. She was a noted champion of women's rights, a leading Canadian author and was actively involved in the implementation of Prohibition. Nellie McClung was a Liberal Member of the Alberta's Legislative Assembly representing Edmonton from 1921 to 1926. She was the first woman appointed to the Canadian Broadcasting Company's Board of Governors and was instrumental in helping women gain the right to sit on the Canadian Senate. After making Edmonton her home for 18 years, Nellie McClung moved to Victoria where she died in 1951 at the age of 77.

The electoral division of Edmonton-Roper was named in recognition of Elmer Ernest Roper who was born at Ingonish, Nova Scotia on June 4, 1893. At the age of 14 he began his apprenticeship in the printing business. In 1917 Mr. Roper came to Edmonton to be the foreman of the Edmonton Bulletin's pressroom. He was active in the Labour Movement and the formation of the Labour Party in Alberta and, later, the Co-operative Commonwealth Federation (C.C.F.). Mr. Roper was elected to the Alberta Legislature in 1942 as Leader of the C.C.F. Party and held a seat representing Edmonton until 1955. Mr. Roper was elected Mayor of Edmonton in 1959 and held that position until 1963. Elmer Roper and his wife moved to Victoria, British Columbia, in 1975.

Edmonton-Rutherford was chosen to honour the Honourable Alexander C. Rutherford who was born in 1857 near Osgoode, Ontario. Alexander C. Rutherford was educated in and practised law in Ontario before moving to Edmonton in 1895 where he set up his own law practice. He became President of the Liberal Party of Alberta in 1905 and was chosen by Sir Wilfred Laurier to be Alberta's first Premier. He won the following election. He always had a keen interest in education, serving as Minister of Education as well as Premier. He served as Premier until 1910 and as MLA representing Strathcona until 1913. Alexander C. Rutherford was instrumental in the development of the University of Alberta and served as Chancellor of the University of Alberta from 1927 until his death in 1941.

Athabasca - Wabasca, Barrhead-Westlock, Calgary - Nose Creek, Calgary - Varsity, Cardston - Chief Mountain, Clover Bar-Fort Saskatchewan, Cypress-Medicine Hat, Edmonton-Ellerslie, Edmonton-Mayfield, Grande Prairie-Smoky, Grande Prairie-Wapiti, Lac La Biche-St. Paul, Lacombe-Stettler, Lakeland, Pincher Creek-Macleod, Redwater, Spruce Grove-Sturgeon, Three Hills-Airdrie, Vegreville-Viking and Whitecourt-Ste. Anne are new designations of electoral divisions that reflect traditional and native names, historical designations or areas of importance within these electoral divisions.

### 6. Reference to the Court of Appeal

Following review of recommendations in this report by the Legislature the resulting legislation will be directed to the Alberta Court of Appeal as a reference question in order to ascertain that the legislation complies with the Canadian Charter of Rights and Freedoms and is therefore fair and equitable for all Albertans.

1 In this Act, "Commission" means an Electoral Boundaries Commission appointed pursuant to section 2.

#### Electoral Boundaries Commission

- **2**(1) From time to time as required by this Act, an Electoral Boundaries Commission shall be established consisting of
  - (a) a chairman appointed by the Lieutenant Governor in Council who is
    - (i) a judge of the Court of Queen's Bench, the Court of Appeal or the Provincial Court, or
    - (ii) a retired judge of any of those courts or of the former district courts or Supreme Court of Alberta,
  - (b) one person, who is not a member of the Legislative Assembly or an employee of the Government, appointed by the Speaker of the Legislative Assembly on the nomination of the Leader of Her Majesty's loyal opposition, in consultation with the leaders of the other opposition parties represented in the Legislative Assembly,
  - (c) 2 persons, who are not members of the Legislative Assembly or employees of the Government, appointed by the Speaker of the Legislative Assembly on the nomination of the President of the Executive Council, and
  - (d) the Chief Electoral Officer.
- (2) Two of the members of the Commission must be resident in a city and 2 of the members must be resident outside a city at the time of their appointment.

#### **Function**

3 The function of a Commission is to make proposals to the Legislative Assembly as to the area, boundaries and names of the electoral divisions of Alberta in accordance with the rules set out in Part 2.

#### Remuneration

- **4**(1) Members of a Commission may be paid the remuneration prescribed by the Lieutenant Governor in Council for their services on the Commission.
- (2) The members of a Commission may be paid their reasonable travelling and living expenses while away from their ordinary place

of residence in the course of their duties as members at the rates the Lieutenant Governor in Council prescribes.

# Time of appointment

- **5**(1) A new Commission shall be appointed during the first session of the Legislature following every 2nd general election after the appointment of the last Commission.
- (2) Notwithstanding subsection (1), if less than 8 years has elapsed since the appointment of the last Commission, a new Commission shall be appointed
  - (a) no sooner than 8 years, and
  - (b) no later than 10 years

after the appointment of the last Commission.

#### Report to Speaker

- 6(1) The Commission shall, after considering any representations to it and within 9 months of the date on which the Commission is appointed, submit to the Speaker of the Legislative Assembly a report, which shall set out the area, boundaries and names of the proposed electoral divisions.
- (2) On receipt of the report, the Speaker shall make the report public and publish the Commission's proposals in The Alberta Gazette as soon as possible.
- (3) If the office of Speaker is vacant, the report shall be submitted to the Clerk of the Legislative Assembly, who shall comply with subsection (2).

#### Hearings

- 7(1) The Commission
  - (a) may before its report is submitted to the Speaker, and
  - (b) shall after its report has been made public,

hold public hearings at the places and times it considers appropriate to enable representations to be made by any person as to the area and boundaries of any proposed electoral division.

(2) The Commission shall give reasonable public notice of the time, place and purpose of any public hearings held by it.

# Amendment of report

8(1) The Commission may, after considering any further representations made to it and within 6 months of the date it

submitted its report, submit to the Speaker any amendments to its report it considers advisable.

- (2) On receipt of the report, the Speaker shall make the amendments public and publish them in The Alberta Gazette.
- (3) If the office of Speaker is vacant the report shall be submitted to the Clerk of the Legislative Assembly, who shall comply with subsection (2).

#### Report to Assembly

- **9** After the Commission has complied with sections 6 to 8, the report of the Commission, together with any amendments to it, shall.
  - (a) if the Legislative Assembly is sitting when the report is submitted, be laid before the Assembly immediately, or
  - (b) if the Legislative Assembly is not then sitting, be laid before the Assembly within 7 days after the beginning of the next ensuing sitting.

#### New electoral divisions

- 10(1) If the Assembly, by resolution, approves or approves with alterations the proposals of the Commission, the Government shall, at the same session, introduce a Bill to establish new electoral divisions for Alberta in accordance with the resolution.
- (2) The Bill shall be stated to come into force on Proclamation and, if enacted, shall be proclaimed in force before the holding of the next general election.

#### Report by Chief Electoral Officer

11 After the results of each census under the Statistics Act (Canada) become available, the Chief Electoral Officer shall submit a report to the Speaker indicating those electoral divisions that no longer comply with section 17 and the extent of the non-compliance.

#### REDISTRIBUTION RULES

#### Definitions

12 In this Part,

(a) "multi-municipality electoral division" means a multimunicipality electoral division referred to in section 15;

- (b) "municipality" includes, for the purposes of this Part, a Metis settlement and an Indian reserve;
- (c) "single municipality electoral division" means an electoral division that consists only of part of or the whole of one municipality;
- (d) "population" means the population of Alberta as determined by the most recent census available under the *Statistics Act* (Canada) at the time a Commission is appointed.

# Electoral divisions

- 13(1) The Commission shall divide Alberta into 83 proposed single municipality electoral divisions and multi-municipality electoral divisions in accordance with this Part.
- (2) In addition to the proposed single municipality electoral divisions required by section 14, all the municipalities named in section 14 may contain part or parts of one or more proposed multi-municipality electoral divisions under section 15.

#### Single municipality electoral divisions

- 14 There shall be 43 proposed single municipality electoral divisions as follows:
  - (a) 19 electoral divisions entirely within The City of Calgary;
  - (b) 17 electoral divisions entirely within The City of Edmonton:
  - (c) 2 electoral divisions entirely within The City of Lethbridge;
  - (d) one electoral division entirely within The City of Medicine Hat;
  - (e) one electoral division entirely within The City of Red Deer;
  - (f) one electoral division entirely within The City of St. Albert;
  - (g) one electoral division entirely within The City of Fort McMurray;
  - (h) one electoral division entirely within The County of Strathcona that includes the hamlet of Sherwood Park.

Multimunicipality electoral divisions 15 There shall be 40 proposed multi-municipality electoral divisions as follows:

- (a) one electoral division consisting of
  - (i) the part of The City of Red Deer not included in a single municipality electoral division under section 14, and
  - (ii) all or part of one or more other municipalities;
- (b) one electoral division consisting of
  - (i) the part of The City of Medicine Hat not included in a single municipality electoral division under section 14, and
  - (ii) all or part of one or more other municipalities;
- (c) one electoral division consisting of
  - (i) the part of The City of St. Albert not included in a single municipality electoral division under section 14, and
  - (ii) all or part of one or more other municipalities;
- (d) 2 electoral divisions, each consisting of
  - (i) part of The City of Grande Prairie, and
  - (ii) all or part of one or more other municipalities,

with all of that City being included in those 2 electoral divisions:

- (e) 35 electoral divisions consisting of
  - (i) more than one municipality,
  - (ii) one or more municipalities plus parts of one or more other municipalities, or
  - (iii) parts of more than one municipality.

#### Relevant considerations

- 16 In determining the area to be included in and in fixing the boundaries of the proposed electoral divisions, the Commission, subject to section 17, may take into consideration any factors it considers appropriate, but shall take into consideration
  - (a) the Canadian Charter of Rights and Freedoms,

- (b) sparsity and density of population,
- (c) common community interests and community organizations, including those of Indian reserves and Metis settlements,
- (d) the number of municipalities and other local authorities,
- (e) geographical features, including existing road systems, and
- (f) the desirability of understandable and clear boundaries.

Population of electoral divisions

- 17(1) The population of a proposed electoral division must not be more than 25% above nor more than 25% below the average population of all the proposed electoral divisions.
- (2) Notwithstanding subsection (1), in the case of no more than 5% of the proposed electoral divisions, if the Commission is of the opinion that at least 4 of the following criteria exist in a proposed electoral division, the electoral division may have a population that is as much as 50% below the average population of all the electoral divisions:
  - (a) the area of the proposed electoral division exceeds 20 000 square kilometres;
  - (b) the total surveyed area of the proposed electoral division exceeds 15 000 square kilometres;
  - (c) the total length of primary and secondary highways within the proposed electoral division exceeds 1000 kilometres;
  - (d) the distance from the Legislature Building in Edmonton to the nearest boundary of the proposed electoral division by the most direct highway route is more than 150 kilometres;
  - (e) there is no town in the proposed electoral division that has a population exceeding 4000 people;
  - (f) due to economic factors there has been a significant loss of population in the proposed electoral division between the 2 most recent censuses available under the Statistics Act (Canada);
  - (g) to impose a higher population requirement would significantly and negatively affect the community of interests of the inhabitants of the proposed electoral division.

(3) For the purpose of subsection (2)(e), The Municipality of Crowsnest Pass is not a town.

#### PART 3

#### TRANSITIONAL

#### Transitional

- **18**(1) The Commission to be appointed during the first session of the 22nd Legislature of the Province shall be appointed during the 2nd session of the 22nd Legislature of the Province.
- (2) The Commission appointed under subsection (1) shall submit its report under section 6 nine months after this Act comes into force.

# Administrative support

- 19(1) The Speaker shall appoint a person who is to be responsible for providing the administrative support for the Commission appointed under section 18(1).
- (2) The Speaker shall take into account the unanimous recommendation of the Select Special Committee on Electoral Boundaries that the administrative support be provided by the Senior Administrator of the Select Special Committee.

#### Repeal

**20** The Electoral Boundaries Commission Act, RSA 1980 cE-4, is repealed.





CITY OF GRANDE PRAIRIE SPLIT














ST. ALBERT
